ORDER

Consonant to the approval of the Board of Governors, NIT Mizoram in its 34th Meeting dated 14.02.2023 through Circulation, which is based on the Competitive Written Examinations held on 24.01.2023 and on the recommendations of the Selection Committee of NIT Mizoram, the Chairman, Board of Governors cum Director, NIT Mizoram is pleased to appoint **Ms. Angana Biswas** (Roll No. NT2022A/LIA-01), D/o Rajib Biswas, Aeronautical Development Agency (Min. of Defence), Vimanapura Post, Bangalore - 560 017 to the post of **Library & Information Assistant (LIA) (1 – UR)**, Group 'B', Non-Teaching, **in the Pay Level 6**; **Cell 1 (as per 7th CPC)** or PB-2 (9300-34800) + GP Rs. 4,200, at National Institute of Technology Mizoram.

- 4) The service conditions of the selected candidate will be governed as per NITSER Act and the NITs Statutes.
- 5) The services of the selected candidate will be governed by the **National Pension System (NPS)** of the Government of India which is in effect from 2004.
- 6) The selected candidate shall perform their duties, as may be assigned by the competent authority of the Institute, from time to time.
