NIT Mizoram invites sealed Expression of Interest (EoI) from eligible Company/Firm/Organisation/Individual for Bus Services (18 nos.) at National Institute of Technology Mizoram.

TERMS OF REFERENCE:

- 1. THAT the normal route will be **Chaltlang to Durtlang**. During the Institute's vacation (Summer & Winter) period, the vehicle shall be available/On-Call Duty round the clock (24x7) at the disposal of NIT Mizoram and the monthly hiring charge will be paid in full to the contractor. However, actual duty hours and place of duty shall be specified, as per the direction/allotment by the GAD, NIT Mizoram. Travelling outside Aizawl Municipal Corporation (AMC) area shall be claimed at the prevailing rate of the State Government (Mizoram)/State Transport Authority (Mizoram).
- 2. THAT the party No. 2 (NIT Mizoram) shall pay

i) Bus with 24+1 Seater & Above, Not older than <u>8 years</u>. <u>Rs. 58,000.00</u> per month or below.

- ii) Bus with yellow color (with valid permit for Educational Institute) shall be exempted from the restriction of the above Clause: "Not older than 8 years".
- **3.** THAT the Expression of Interest without Registration Certificate, State Transport Authority Certificate, Valid Insurance Certificate, Road Tax Clearance, Fitness Certificate, Route Change/Plying Permit issued by State Transport Authority etc. as provided in **Annexure II** shall be summarily rejected.
- 4. THAT the Party No. 2 shall make No payment in advance nor any loan from any Bank or Financial Institutions shall be recommended on the basis of the order of the award of the work. The Party No. 1 (Contractor) shall submit the monthly bill with the Vehicle Diary, duly signed by the authorized officer of the Institute in the first week of following month in respect of previous month's performance. The Monthly Bill shall be paid only after tax deduction at source (TDS) as applicable from time to time.
- 5. THAT the Party No. 2 shall ply wherever need occurs for extra duty without extra payment, except for Inter-District/Inter-State duty. This is a duty in lieu of payment to be made on monthly basis during the Institute's vacation (Summer & Winter) period.
- 6. THAT the Party No. 1 shall supply the properly cleaned vehicles on the exterior and properly cleaned and totally dust free interiors. Seats of the vehicle should have clean covers and drivers should be properly dressed and well behaved. Engine of the supplied vehicle should be well maintained and noise/pollution free as mandated by the Transport authorities of the Govt. of Mizoram and the Pollution Control Board, Mizoram.
- 7. THAT the Driver/Conductor and vehicle should not be changed frequently. The engagement and employment of drivers and payment of wages to them as per the

existing provision of various Labour Laws and Regulations is the sole responsibility of the Contractor and shall indemnify the NIT Mizoram. Any breach of such laws on regulation shall be deemed to be breach of this contract. If in most unavoidable circumstances the change of driver/ vehicle is required, prior intimation (at least 2 days) shall be given to the NIT Mizoram. The Vehicle Diary will be provided to the selected bidders by the Institute. Joining/Termination on any day of the month shall be counted on pro-rata basis in the monthly bill.

- 8. THAT the Party No. 1 shall be responsible for arrangement of space for parking of the vehicle.
- 9. THAT the cost of P.O.L, expenditure for vehicle maintenance, repair and any other incidental expenditure shall be borne by Party No. 1. No hike in rate will be allowed if there is a hike in the price of POL and or spare parts of vehicle during the Contract Period.
- 10. THAT the Party No.2 reserves the right to call the vehicles before stipulated duty hours and beyond duty hours for duty in NIT Mizoram. In case of breakdown, if the vehicle is not replaced within one hour, penalty of **Rs. 500/-** per occasion will be imposed, in addition to the pro-rata deduction of rental in the monthly bill. Vehicles should be made available on call basis beyond duty hours and beyond the week days as well as holidays, failing which the penalty of **Rs. 1,000/-** will be imposed on each occasion.
- 11.THAT in case the Party is not satisfied with the quality/condition of the vehicle, the Party No. 1 shall change the vehicle/make necessary repairs to the satisfaction of the NIT Mizoram. (The NIT Mizoram reserves the right to counter offer price against the price quoted by the Party No.1).
- 12. THAT the Party No. 1 shall solely be responsible for violation of traffic rules or any other breach of law in force. The drivers and conductors should not indulge in any kind of intoxication, alcoholic beverages etc and smoking inside the bus. Violation of this section shall invite a fine upto ₹1,000.00 to be borne by Party No. 1.
- 13. THAT the Party No. 1 shall not utilize the BUS for any other purpose other than NIT Mizoram Services.
- 14. THAT under normal circumstances, the contract shall be valid for a period of **one year** from the date of issue of Contract Order. The Party No.2 may cancel the contract during the contract period without assigning any reason. However, the contract may be extended subsequently, on mutual consent without resorting to public tender/EoI only with the written consent of the Contractor, and on same terms and conditions for a period of **one year** at a time (upto a maximum of three years) on review of performance. However, if contract is to be extended for more

than one year, continuously, the present terms and conditions shall be **revised**, without fail, if the need arises and at the sole discretion of the Institute.

- 15.THAT the Party No.1 shall follow orders and instructions of the NIT Mizoram authority and abide by security instructions/procedure during the contract period.
- 16. THAT NIT Mizoram reserves the right to increase or decrease numbers of hired buses at any given time, at the sole discretion of the Institute.
- 17. THAT the Competent Authority of NIT Mizoram, without prejudice to any other remedy, for breach of contract, may terminate the contract in whole or in parts.
 - a) If the Contractor fails to arrange the supply of any or all of the vehicles within the period(s) specified in the contract or any extension thereof granted by competent authority.
 - b) If the Contractor fails to perform any other obligation (s) under the General & Special Conditions of the contract and all clauses of this EoI which are integral part of this EoI.
 - c) Competent authority may without prejudice, to other rights under law or the contract provided get the hiring of vehicles done at the risk and cost of the Contractor, in above circumstances.
- 18. **Termination for Insolvency:** The Competent Authority may at any time terminate the Contract by giving written notice to the Contractor, without compensation to the Contractor.
- 19. THAT Disputes if any, to be settled under the jurisdiction of Gauhati High Court, Aizawl Bench, Aizawl Mizoram.
