Terms and Conditions for Appointment of Ah-hoc Assistant Professor:

- 1] The appointment will be purely on *Ad-hoc* basis with consolidated pay of ₹. 50,000/- (Rupees Fifty Thousand only) per month initially for a period of One Year liable to be extended/curtailed at the discretion of the competent authority.
- 2] No other service benefits at par with the regular employees of the Institute will be admissible.
- 3] The appointees are expected to produce relieving certificate, if applicable at the time of joining.
- 4] A contract agreement will have to be signed with the Institute on ₹. 100/- non-judicial stamp paper before joining the post.
- 5] Caste Certificates will be verified through the proper channel and if the verification reveals that the claim to belong to OBC (non-creamy layer as per the new format)/SC/ST (as applicable) is false and/or their caste certificates are invalid, their service will be terminated forthwith without assigning any further reasons, and without any prejudice to such further action may be taken under the provisions of the Indian Penal Code for production of false certificates.

- 6] The contract of the person appointed may be terminated by either side with a one month prior written notice to the Institute. The Institute will be at liberty to terminate the contract of the person at any time with immediate effect by paying the consolidated pay of one month in lieu of one month notice.
- 7] 2½ (Two and half) days Earned Leave will be admissible for each completed month of contract service as per CCS (Leave) Rules.
- 8] In case if appointee is willing to resign from his/her post at NIT Mizoram at any time, he/she may be released from the Institute only after completion of all the formalities of the on-going semester.
- 9] The appointed person is required to join the post immediately preferably on or before 15th May, 2015 after getting the offer letter through e-mail/fax.
