NOTICE INVITING QUOTATION (NIQ)

National Institute of Technology Mizoram is one of the ten new NITs established by Ministry of Human Recourse Development, Government of India, New Delhi in the year 2010 at Aizawl, Mizoram to impart education, training and research in Science, Technology and Management leading to award of B. Tech., M. Tech., MBA and Ph. D degrees. This institute is fully financed and governed by Ministry of Human Recourse Development, Government of India.

Sealed Quotations are invited from eligible Manufacturers/Developers or their Authorized Dealers for supply of Glassware (given in Annexure-I) to reach the undersigned on or before 16th November 2015 before 2:00 PM. Date/Time for Opening of sealed Quotations is 17th November 2015, 2:30 PM at NIT Mizoram, Aizawl.

General Instructions for the Bidders:

01. Quotations are to be submitted in a sealed **envelope specifically mentioning "Quotations for Supply of Glassware for DST-SERB Project"**.
02. **Bid not transferable:** The bid documents are not transferable and the seal and signature of the authorized official of the firm must appear on all the papers submitted.

QUALIFICATION REQUIREMENTS

01. The Bidder should be an Original Equipment Manufacturer (OEM) or a firm of reputation having sufficient expertise and experience in the subject tender with sound warranty/service support capability and authorization from Manufacturer/Distributor.

TERMS & CONDITIONS:

01. **Rates:** Rates quoted in the **Quotations** should be **on DOOR DELIVERY NIT Mizoram basis**, as per given in **Annexure-I**. Bidders shall indicate their rates in clear/visible figures as well as in words and shall not alter/overwrite/make cutting in the quotation. In case of a mismatch, the rates written in words will prevail.
02. **Validity of Quotation:** Quoted rates must be valid for **90 days** from the date of quotation.
03. **Delivery:**
 - a) **Time Limit:** Maximum within 12 Weeks from the date of issue of the purchase order.
 - b) **Safe Delivery:** All aspects of safe delivery shall be the exclusive responsibility of the vendor.
 - c) **Insurance:** The supplier is to establish 'All Risk Transit Insurance' coverage till door delivery at NIT Mizoram.
 - d) **Part Delivery:** Acceptance of part delivery shall be a prerogative of the institute.
 - e) **Penalty for delay in delivery:** The date of delivery should be strictly adhered to otherwise the Director, NIT Mizoram reserves the right not to accept delivery in part or full.
04. **Genuine Pricing:** Vendor is to ensure that quoted price for the particular item is not more than the price quoted to any other customer in India, particularly to IITs/NITs and other Government Organization.
05. **Conditional quotations not acceptable:** All the terms and conditions mentioned herein must be strictly adhered to by all the vendors. Conditional tenders shall not be accepted on any ground and shall be rejected straightway. Conditions mentioned in the tender bids submitted by vendors will not be binding on NIT Mizoram.

06. **Road Permit:** NIT, Mizoram will provide Road Permit/Way bill upon request.

07. **VAT deduction at source:** In case of supply within Mizoram, VAT deduction at source, as per Order/ notification of the Govt. of Mizoram will be applicable.

08. **Late and delayed tender:** Late and delayed quotations will not be considered. In case any unscheduled holiday occurs on the prescribed closing/opening date the next working day shall be the prescribed date of closing/opening.

09. **Payment:** 100% payment within 30 (Thirty) days after receipt of the material in full.

10. **Enquiry during the course of evaluation not allowed:** No enquiry from the bidder(s) shall be entertained during the course of evaluation of the tender till final decision is conveyed to the successful bidder(s). However, the Purchase Committee or its authorized representative may make enquiries/seek clarification from the bidders. In such a case, the bidder must extend full co-operation. The bidders may also be asked to arrange demonstration of the offered items, in a short period of notice.

11. The acceptance of the quotation will rest solely with the Director, NIT Mizoram, who in the interest of the Institute is not bound to accept the lowest quotation and reserves the right to himself to reject or partially accept any or all the quotations received without assigning any reasons.

12. Force Majeure:

If the performance of the obligation of either party is rendered commercially impossible by any of the events hereafter mentioned that party shall be under no obligation to perform the agreement under order after giving notice of 15 days from the date of such an event in writing to the other party, and the events referred to are as follows:

- i. Any law, statute or ordinance, order action or regulations of the Government of India,
- ii. Any kind of natural disaster, and
- iii. Strikes, acts of the Public enemy, war, insurrections, riots, lockouts, sabotage.

13. Applicable Law:

(a) The contract shall be governed by the laws and procedures established by Govt. of India and subject to exclusive jurisdiction of Competent Court and Forum in Aizawl only.

(b) Any dispute arising out of this purchase shall be referred to the Director NIT Mizoram, and if either of the parties hereto is dissatisfied with the decision, the dispute shall be referred to the decision of an Arbitrator to be appointed by the Director of the Institute. The decision of such Arbitrator shall be final and binding on both the parties.
