Background:

Applications are received from the Supervisor of 5(Five) Ph.D students seeking the extension of 1(one) year extension by the Chairman, Senate through the Dean (Academics). The 5 (five) PhD students tabulated below had taken admission in March, 2017 and as per clause 19 (ii) of the Ph.D Regulation "The maximum duration of the Ph.D Programme is 5 years for a FULL TIME student", hence, being regular students they have to complete within 5(five) years.

Their applications for extension of 1 year have been recommended by the Doctoral Committee and approved without stipend by the Chairman, Senate.

Ratified. After detailed deliberation, the Senate decided that Ph.D students during the extended 6th year, when they are without fellowship / stipends, may be provided solation, in terms of granting nominal amount of financial sustenance.

During the 6th year (extended year), the Ph.D students may be engaged to give tutorials / lab classes etc.

RATIFICATION OF APPROVAL TO MODIFY THE RESEARCH OBJECTIVE BASED ON THE RECOMMENDATION OF THE DOCTORAL COMMITTEE FOR MR. ANURAG JHA.

Background:

The Senate is informed of the case of one Ph.D student - Mr. Anurag Jha, Enrolment No. DT19ME007, Department of Mechanical Engineering, who is a Part Time Scholar under the Supervisorship of Dr. Basil Kuriachen, Assistant Professor, Dept. of Mechanical Engineering (on lien to NIT Calicut). The student presented the State Of Art Seminar (SOAS) on 17.01.2022, report of the State Of Art Seminar (SOAS) is placed at **Annexure I of SNT 18.5 at page no. 45.** Comments and Observation of the Doctoral Committee is as given:

- Mr. Anurag Jha presented literature survey, the gap in the literature identified and objectives in front of the Doctoral Committee. However, the Doctoral Committee observed that the gaps identified and derived objectives are not sufficient enough to allow Mr. Anurag Jha to continue with the research. Hence, the Doctoral Committee recommended modifying the research objectives based on a thorough literature survey and presenting the same in front of the Doctoral Committee in the upcoming Semester.
- Also, Doctoral Committee recommends Mr. Anurag Jha to register for the next Semester.

Clause 13(iv) of the Ph.D Regulations states that "Within a month, a student delivers another SOAS if the first SOAS is not satisfactory". While delivering of another SOAS should be within a month's time as per the Ph.D Regulations, the DC's recommendation is to modify "the research objectives based on a through literature survey and presenting the same in front of the DC in the upcoming Semester". As recommended the same was approved by the Chairman, Senate to allow modification of the research objectives and for registration in the next Semester i.e. ODD Semester commencing from July, 2022.

The matter is brought to the Senate for information and ratification of the approval of Chairman, Senate.

Decision of the Senate:

Ratified. However the Senate decided that one months' time for a student to deliver another SOAS is too short a time and shall be extended to 3 months duration. Accordingly Clause 13(iv) of the Ph.D Regulations shall be amended.

RATIFICATION OF THE APPROVAL TO CONDUCT COMPREHENSIVE EXAMINATION AFTER 18 MONTHS

Background:

Clause 12(i) of the Ph.D Regulations states that "To test the overall competence and academic preparation of a student in the Ph.D programme, a Comprehensive Examination is to be conducted within 18 months of joining for students with masters' degree and within 24 months of joining for the student with only Bachelor Degree." Copy of the Ph.D. Regulations is placed at Annexure I of SNT 18.6 at page no 46 - 58.

While the Regulations is as above, of Mr. Dipanjan Paul, Enrolment. No. DT19ME002 (Part-Time/External, Ph.D Scholar) on account of the unfortunate demise of the Supervisor, Late Dr. Abhijit Sinha, Assistant Professor on 08.06.2021 could not complete his Comprehensive Examination within 18 months of his being admitted into the Ph.D Programme w.e.f. 2019-20 (ODD Semester 2018). The Ph.D student has completed 24 Credit with 7.50 GPA till the 1st Semester. Copy at Annexure II of SNT 18.6 at page no. 59.

The Supervisorship was handed over to Dr. H. Lalhmingsanga, Assistant Professor (ME) as per the decision of the 16th Meeting of the Senate on 24.07.2021.

Due to the aforesaid reasons, the delay was condoned and *ex post facto* approval was accorded, as a special case, by the Chairman, Senate, as it is beyond 18 months of the initial registration to Ph.D Programme. Hence, Comprehensive Examination was conducted satisfactorily on 03.02.2022 through Video Conferencing.

The matter is placed for information and ratification of the Senate.

PROPOSAL FOR SIGNING OF MOU FOR ACADEMIC AND RESEARCH COLLABORATION BETWEEN NIT MIZORAM AND HT MADRAS

Background:

This is to place before the Senate the proposal for signing of Memorandum of Understanding between NIT Mizoram and IIT Madras, for academic and research collaboration. This will provide the scope for facilitating the under-mentioned areas:

- Academic and Research collaboration in the areas of mutual interest
- Exchange of academic information, scholarly information, materials and publications
- Exchange of students and faculty
- Sponsorship of cooperative seminars, workshops and other academic meetings.

The MoU will facilitate admission of the top 10% of the students of NIT Mizoram at the end of the 6th Semester to enable meritorious students to pursue the 7th & 8th Semesters of the B.Tech Programme at IIT Madras and subsequent admission to higher education at IIT Madras i.e Direct Ph.D program at IIT Madras, as per the terms and conditions provided.

SNT 18.11.1 Information regarding the word modified format of the UG & PG Academic Transcript

Background:

The 7th Deans' Committee held on 02.05.2022 under the aegis of the Director and Registrar, NIT Mizoram decided that the Academic Transcript of the UG & PG students, passing out from the year 202 onwards will have their Academic Transcripts with the column "Passed in" excluded and that the word "Backlog" would no longer be inserted in the Academic Transcript. There will be no change in the Grade Card.
