Welcome address by Prof. S. Sundar, Director, NIT Mizoram.

- The Director extended gratitude to the Dean-SW and the entire faculty fraternity for having successfully arranged the Orientation Programme for the B.Tech Freshers' on 18.11.2022.
- The unhealthy incident which occurred on 18.11.2022 at the Lunch Room-Academic Block-8, indicating an altercation between the student-hostellers and the Mess workers (outsourced services) portrays students' misconduct. The Student Disciplinary Committee should immediately take enquiry under the aegis of Dean-SW.

Such misconduct of students' should be handled with zero tolerance and appropriate action i.e. rustication of the students' at fault may be meted out etc. All damages caused shall be recovered from the defaulting students'. All students' are to be educated to respect NIT Mizoram and its facilities and amenities. The instant case is to be resolved on a strong note that students' cannot take physical offence within the perimeters of NIT Mizoram.

• No compromise on teaching. Time schedule of causes to be strictly followed by all Teachers. No compensation of lost classes, Teachers are advised not to 'outsource' classes.
