MINUTES OF THE 3rd DEANS' COMMITTEE dated 04.04.2022

Attendance is at Annexure - I

Welcome address by Prof. S. Sundar, Director, NIT Mizoram. The Director stated that laboratories needs to be increased and improved and that placements are to be increased.

- ➤ Meeting Minutes of 28.03.2022 stands confirmed. IQAC be constituted and established.
- As initiated by the Director, finalization of marks (B.Tech) be effected through constitution of respective Class Committees in 3 stages (i) Before exams (ii) Before marks are uploaded in the ERP (iii) Before declaration of the results. Cut-off marks and distribution of marks to be deliberated by the respective Class Committees. Class Committees be constituted for every branch/course at the beginning of the Semester with one student representative.
- ➤ LTC availing by faculty during a Semester may be addressed by incorporating the minimum number of LTC availed by teachers in the Regulations/Ordinances.
- During internship/placement/training, attendance is to be normalised and to ensure that minimum 75% attendance is not compromised.
- > Teacher's feedback to be initiated from the on-going Semester.
- Change of Supervisorship of PhD student Mr. Iqbal Khan, Enrolment No. DT20CE005, Department of Civil Engineering to be reported to the Senate.
- All faculty to apply and secure SERB Projects.

- ➤ To source internal funding for those projects suffering from under-financing, so as to provide buffer. To be implemented when corpus fund of the Institute is stabilised.
- ➤ The Director emphasized on the need to go for "Shadow Placements" i.e. to those passed out students who are looking for jobs, even after a gap of 2 3 years of passing out.
