BOG 41.CIR.-2	<p>Seeking approval for inclusion of One Time Age Relaxation Clause in NIT Mizoram Non-Teaching Recruitment Advertisement. (Circulated on 13.11.2024)</p> <p>Background: This is to place before the Board an information and seeking administrative approval on the under mentioned points:</p> <p>(i) Pursuant to the sanction of various Non-Teaching posts at NIT Mizoram from the Department of Higher Education, Ministry of Education, Govt. of India vide Letter No. F. No. 26 – 3/2023 TS.III dated 4th June, 2024, NIT Mizoram has taken immediate step and published Advertisement for Recruitment of Non-Teaching positions on Mission Mode vide Notification No. NITMZ/R-1-15/NT/2024/2119 dated 28.10.2024. Copy of the Advertisement for Recruitment of Non-Teaching positions is placed at Annexure - I of BoG 41.CIR.-2.</p> <p>(ii) In this regard, it is pertinent to seek administrative approval of the Board of Governors for inclusion of “One Time Age Relaxation” Clause for Employees who are working on ad-hoc/ temporary / contractual / outsource basis in NIT Mizoram, in addition to the existing General Instructions and Information, as the same being implemented in other NITs, which is in line with the Point A. (i) of the “Recommendations of Oversight Committee for removal of anomalies of non-teaching staff and revised Recruitment Rules (RRs) for Non-Teaching in the NITs” issued by the Department of Higher Education, Ministry of Education, Govt. of India vide Letter No. F. 35-5/2018-TS.III dated 20.02.2019 and extant Recruitment Rules (RRs) for Non-Teaching in the NITs – 2019. Copy of the Recommendations of Oversight Committee is placed at Annexure - II of BoG 41.CIR.-2.</p>

	<p>One Time Age Relaxation Clause:</p> <p>“Those Employees, who are presently working on <i>ad-hoc/ temporary / contractual / outsource basis in NIT Mizoram</i> will be given age relaxation equivalent to the number of years served at NIT Mizoram with the upper age limit up to 56 years. This clause is applicable for only those who were working with NIT Mizoram on the date of Notification of Recruitment Rules for Non-Teaching Staff of NITs – 2019 i.e 20.02.2019 and still continuing in service at NIT Mizoram. The age relaxation will be applicable only for participation in this particular recruitment process. No relaxation in qualification and experience will be applicable under any circumstances.”</p> <p>On the strength of the above points, approval of the Board of Governors is hereby sought through Circulation for inclusion of “One Time Age Relaxation” Clause for Employees who are working on ad-hoc/ temporary / contractual / outsource basis in NIT Mizoram, in addition to the existing General Instructions and Information in the Advertisement for Recruitment of Non-Teaching positions on Mission Mode vide Notification No. NITMZ/R-1-15/NT/2024/2119 dated 28.10.2024.
