A. Admission into M. Tech (Part-time) Programme:

Applications are invited from the eligible candidates for admission into M. Tech (Part-time) programme of NIT Mizoram Through Institute Mode for the academic session 2024-25. The selected Part-time M. Tech students will receive no financial assistance or stipend from the institute.

The course duration shall be three (3) years; two (2) years for coursework and one year for project work). This programme has been extended to eligible candidates working in a full-time job, project, etc., and residing within Aizawl city, upon submission of a proper **No Objection Certificate (NOC)** from the concerned employer.
