ORDER

It is unfortunate that **Ms. Lalnunhlimi (NH-i)**, Sanitation Service Staff at Administrative Block, NIT Mizoram is **tested COVID-19 positive on Dt. 29.08.2021**.

Pursuant to this, as per the SOP of Government of Mizoram and Central Government issued from time to time, the **Administrative Block**, NIT Mizoram located at Chaltlang Dawrkawn will remain closed for **10 days i.e with effect from 01.09.2021 till 10.09.2021** or until Ms. Lalnunhlimi (NH-i)'s test report is proven negative, whichever is earlier.

And as precautionary measures, all NIT Mizoram fraternity who were in direct contact with **Ms. Lalnunhlimi (NH-i)**, Sanitation Service Staff at Administrative Block **since 23rd August, 2021 (Monday)** are advised to isolate themselves at Home with a keen maintenance of their health condition and not to go out anywhere for 10 days. If necessary, to report themselves to their respective LLTF.


