General Terms & Conditions:

- 1] The engagement will be purely on **Contractual** basis with consolidated pay of ₹. **30,000/- (Rupees Thirty Thousand only)** per month for **Counsellor (Contractual)** initially for a period of **1 year** liable to be extended/curtailed at the discretion of the Competent Authority.
- 2] The engagement as Counsellor will be for **6 hours x 6 days a week (9:00am - 3:00pm)**
- 3] The person engaged on contractual basis is hereby informed to join the Institute on or before **1st September, 2022.**
- 4] No other service benefits at par with the regular employees of the Institute will be admissible.

- 5] The appointee is expected to produce relieving certificate, if applicable, at the time of joining.
- 6] A contract agreement will have to be signed with the Institute on ₹. 100/- non-judicial stamp paper before joining the post.
- 7] The Contract entered with the Counsellor (Contractual) is liable to be terminated by the National Institute of Technology Mizoram, without assigning any reason thereof.
- 8] The contract of the person engaged may be terminated with a one month's prior written notice to the NIT Mizoram. The NIT Mizoram will be at a liberty to terminate the contract of the person at any time with immediate effect by paying the consolidated remuneration of one month, in lieu of one month's notice.
- 9] Vide APPENDIX – II of the CCS (Leave) Rules, 1972 and as amended from time to time, the person engaged as Counsellor – on Contract may be liable to avail **Earned Leave of 2.5 days per month** during the engagement period.
