CIRCULAR

In pursuance of the DO dated 03.05.2021 from Secretary (HE), Ministry of Education, Govt. of India and subsequent precautionary measures issued by the Min. of H&FW, GoI to contain the spread of the second wave of COVID-19 Pandemic in most part of the country, NIT Mizoram has decided to take necessary steps and appropriate measures for all fraternity members of the Institute (in-station students, Faculty, Officers, Non-Teaching staff and outsourcing Manpower staff) as under:-

- The Institute will hand out medicine kit consisting of <u>Antibiotics, Paracetamol,</u> <u>Multi vitamins, Vitamin C etc.</u>, through the Health Care Centre, NIT Mizoram, to fraternity members of NIT Mizoram to boost the immune system, w.e.f 11th May, 2021 (Tuesday) through the HCC, NIT Mizoram under the supervision of Dr. Lalnuntlana, Gen. Physician, NIT Mizoram. In the eventuality of Covid-19 symptoms being observed, all fraternity members are hereby advised to contact and liaise with the General Physician Dr. Lalnuntlana (Mob. No. 9612147615) for further treatment protocol.
- 2. It may be also be reiterated that, the Regular Employees who are eligible for Medical Reimbursement under CCS(MA) Rules may be allowed to reimburse the purchase of Thumb Oximeter, as per actual, if duly prescribed by the Physician/AMA.
- 3. In case of Emergency, **Institute's Ambulance** will be duty on call 24 x 7 and the Driver, **Mr. Lalmuankima (Mob. No. 9089312940 / 7642831614)** may be contacted.
- 4. Though Vaccine roll-out to all fraternity of NIT Mizoram was already conveyed to Government of Mizoram during March, 2021 and reminder conveyed in the first week of April, 2021, action is yet to be seen. The Administrative Department is concurrently liaising with the State Government and is hopeful that vaccinations may be rolled out soon for the in-station fraternity members of the Institute. However, the age groups of 18 44 years old may need to hold out as the State Government is in the throes of augmenting the vaccine.
- 5. As for the examination is concern, NIT Mizoram, as per the decision of the Senate, has already conducted all the classes through online mode only for the ongoing semester till July, 2021, and hence the examination may also be conducted through online mode, as the same was successfully conducted in the earlier semester.
