PROPOSAL FOR APPROVAL OF THE ANNUAL ACCOUNTS OF NIT MIZORAM FOR THE FINANCIAL YEAR 2021-2022 FOR REGULAR AUDIT OF THE PAG MIZORAM

Background:

As per the Schedule for preparation of Annual Report and Annual Accounts issued by the Ministry of Education vide F.No.33- 41/2020 - TS.lll dated 06.01.2021, all NITs are to submit the Annual Accounts to the Accountant General (Audit) by 30th June every year.

In an effort to enable the Central Autonomous Bodies in adherence to the above, the CAG has lately devised the procedure and issued Notification vide No: 391/AB/Misc.Corres./04-03/2022 dated 09.06.2022. This was conveyed in the meeting convened by the Sr. Deputy Accountant General, Office of the AG(Audit), Mizoram attended by officials of NIT Mizoram and Mizoram University. The content of the Notification goes as under-mentioned:

"While taking up financial audits in CABs, audit may be taken up with the un-approved accounts to avoid delay. However, the final SARs shall not be issued by the field office to the CAB without ensuring that the accounts have the approval of the Board of Governors (BoG)/ competent authority....".

On the strength of the above Notification, the Annual Accounts for the year 2021-22 was submitted to the AG (Audit) Mizoram Office on 30.06.2022 i.e within the timeline prescribed for submission of the Annual Accounts. Audit started immediately and concluded on the 25.07.2022

Hence, vide Clause 4 (8) of the First Statutes of NITs, the approval of the Finance Committee and Board of Governors is hereby sought through Circulation for the Annual Accounts of NIT Mizoram for the year 2021-22 for regular audit of the AG (Audit). Copy of the Annual Accounts of 2021-22 is placed at **Annexure-I of BoG 30.1.**

The matter is therefore, placed before the FC/BoG for approval.



OH-31: The Non-TSA Fund, instructed for liquidation, has been utilized for subscription of **Turnitin Anti-plagiarism Software** with the approval of the 25th FC and 29th BOG meeting on 25.05.2022 for the amount of Rs. 19.66 Lakh. And in the beginning of the year, the amount of Rs. 1.09 Lakh was utilized for Office Expenses. Hence, total amount of Non-TSA Fund already spent during the year is Rs. 20.76 Lakhs i.e. Rs. 19.66 Lkah + Rs. 1.10 Lakh, thereby, leaving the balance of Rs. 0.28 Lakh, as on date

OH-35: Out of the balance shown in the above table and as instructed for liquidation;

- Rs. 1153.00 Lakhs stands anticipated liability payable to IRCON International Ltd: which cannot yet be resolved due to non-receipt of SAR of the Special Audit 2019 and the on-going dispute in the Arbitral Tribunal, Guwahati
- 2. Rs. 39.10 lakh has been provisioned for other requirements and Capital Assets Creation, which is under process, as on date
- **3.** For Rs. 442.32 Lakhs, provisions have been made purely on need base and duly approved by the 25th FC and 29th BOG meeting on 25.05.2022, as segregated below;
 - a) Development of the Academic Laboratories for Departments of CE, ECE and CSE Rs. 221.52 Lakhs
 - b) Requirements for the Academic Departments towards Computer and Peripherals and Furniture & Fixtures Rs. 54.84 Lakhs
 - c) Requirement for the new Academic Classroom and New Hostels to accommodate 264 increased students Rs. 108.10 Lakhs
 - d) UPS Batteries for the Institute's Server and UPS for 38 faculty and 11 Technical Staff Rs. 17.16 Lakhs

OH-36: Rs. 41.93 Lakhs being balance under OH-36 at the end of the Year has not been utilized

<u>B.</u> Under TSA System, the RBI Account for NIT Mizoram was opened in October 2021. However, the Institute could start with the TSA System from 01.12.2021 due to operational inadequacies

PROPOSAL FOR APPROVAL OF THE SCHEME FOR SCREENING TEST FOR THE POST OF ASSISTANT REGISTRAR

Background:

The Board is hereby informed that Employment Notice for recruitment of Non-Teaching positions of NIT Mizoram was carried out vide No. NITMZ/R-1-11/NT/2022/2478 Dt. 08.07.2022. The post of Assistant Registrar is the only Group 'A' post advertised as 1-UR. The number of applications received for the lone post is 140. This being the position, the provision of Clause 15 of the **General Instructions & Information** of the Advertisement may need to be implemented which goes as -

"The prescribed essential criteria for the post of Assistant Registrar (Group 'A') are the minimum eligibility qualifications and mere possession of the same does not entitle a candidate to be called for the Selection Committee. In the event of applications being large, with respect to the vacant post of Assistant Registrar (1 – UR), NIT Mizoram may resort to short-listing criteria as a means to restrict the number of candidate to be called for the Selection Committee to a reasonable limit by adopting methods devised by NIT Mizoram including holding a Screening Test".

Copy of the **General Instructions & Information** of the Advertisement is placed at **Annexure-I**

In the absence of any approved Scheme for conducting the Screening Test for the post of Assistant Registrar, the Detailed Scheme of Screening Test has been devised which will consist of Two Sections:

Section A: Paper I would be General English

Paper II would be General Studies.

Section B: Interview. Here only those qualifying the



Screening Test will be called for Interview/Selection Committee.

The detailed Scheme of Screening Test is placed at Annexure-II.

It is therefore, proposed that the Scheme of Screening Test may be approved by the Board for immediate implementation for screening the candidates for the post of Assistant Registrar (1-UR).
