NOTICE

It has been noticed, with regret, that the faculty members, officers and staff of NIT Mizoram, listed at Annexure-I, had left their duty posts/headquarters in Chaltlang, Aizawl during the wake of COVID-19 pandemic, without informing the Administrative Department nor obtained permission to leave station/headquarters and had abstained from applying leave of any kind.

The listed regular employees and other adhoc, temporary and contract personnel had committed a grave mis-step and left for their hometowns without conforming to the standing procedures that a Govt. servant ought to follow; a clear indication that the conduct of the aforesaid contravenes the CCS (Conduct) Rules, 1964.

While the CCS (Leave) Rules, 1972 and the standing Fundamental Rules indicates that every Govt. employee is afforded to leave headquarters only after due sanction of leave or after gaining permission for leaving headquarters for official tours, training etc., the aforesaid have been found to have acted without due diligence to the extant Govt. of India Rules and the NIT Statutes.

The aforesaid employees/personnel had left headquarters without authorised permission, the conduct of which is subversive of discipline and appropriate action liable to be taken under F.R. – 17(A), resulting to breaks in service etc.

However, given the prevalent pandemic crisis, the competent authority has decided to refrain from taking action as per Rules but the aforesaid employees/personnel are cautioned and informed not to repeat the inappropriate action, and to maintain discipline at all times, in future.
