NOTICE

In continuation to the Notice issued vide No. NITMZ/Adm./4/2018/378 dated 16th March, 2020, No. NITMZ/Adm./4/2018/379 dated 16th March, 2020 and pursuant to the provisions of the Govt. of India vide The Epidemic Diseases Act, 1897, and the advisory of the Govt. of Mizoram vide The Mizoram Epidemic (COVID-19) Regulations, 2020, the NIT Mizoram hereby undertakes the following measures:

1. All the students, upon return from their home shall strictly observe all the protocol of Preventive Measures on COVID-19 threat being issued by the Ministry of Health and Family Welfare, Govt. of India and Health Department, Govt. of Mizoram, from time to time.
2. Upon return from home/out station, all the students are advised not to enter the Institute's premises directly. All students shall report to the General Physician, Health Care Centre positively, who will undertake the necessary medical protocol, as required.
If the case merits, the General Physician, Health Care Centre shall liaise with the Govt. of Mizoram, Health Department or Nodal Officer, IDSP Mizoram, after consulting the Administrative Department of the Institute.
3. It is reiterated that those students who had journeyed to foreign shores and other states within India during the past 30 days are to report for thermal/medical screening at entry points designated by the Govt. of Mizoram and further report to the General Physician, Health Care Centre, NIT Mizoram without fail.
4. As per the advisory of the Govt. of India and the Govt. of Mizoram, **the policy on home quarantine** shall be applied to all students, *in toto*. Consonant to this, all students who have/will travel to outside the State of Mizoram shall invariably be subject to 14 days home quarantine, immediately after their return to Aizawl, Mizoram / Institute.
5. It has been noticed that some student have stayed on in the Boy's Hostel - I, II, III and IV of NIT Mizoram, without any permission from the Institute's Authority, after 17.03.2020, till date. Those students are hereby informed to report themselves to the respective Warden/ Asst. Warden / Chairman HMC immediately, with proper reason of stay on in the Hostel.

6. The students have stayed on in the Hostel(s) are informed to submit the "Undertakings" which is enclosed with this Notice and submit to the respective Warden/ Asst. Warden/ Matron / Chairman HMC positively by 23rd March, 2020.
7. All the students are advised to visit the Institute's Website regularly.
