In continuation of Notice No. NITMZ/ACAD/1-5/2024/2500 dated **17.01.2025**, the Registration date for the **Even Semester, 2024-2025**, has been extended upto **29.01.2025**. Students of **B.Tech & M.Tech** programme are hereby informed to complete their **Even Semester 2024-2025 Registration** by this extended deadline i.e **29.01.2025**, the physical reporting and late fines are compulsory unless waived by the Institute's competent authority.

As per the decision of 75<sup>th</sup> Dean's Meeting dated **20.01.2025**, the Late fine of **Rs. 2000/-** shall be charged until **29<sup>th</sup> January, 2025** and after **29.01.2025**, the late fine **Rs. 10,000/-** shall be charged from B.Tech & M.Tech students.

Further, for those students who have participated in the **GATE Examination** held in the month of **February 2025**, they are required to physically report to the Institute within **8 days** from the date of the **GATE Examination**. Upon their arrival, the **GATE 2025** online records will be verified by concerned faculty advisors. If any student is found to have submitted false information or fails to report within the specified **8-day** period from the aforesaid examination, a late fine of **Rs. 10,000/-** will be charged to the concerned B.Tech students.
