#### General Terms and Conditions:

1. The engagement will be purely **on Contractual** basis with a consolidated remuneration of ₹. **35,000.00 (Rupees Thirty Five Thousand Only)** per month with working hours of **9:00 AM – 5:00 PM** for a period of **1 (one) year, w.e.f 01.04.2024** or **the date of joining** the duties at NIT Mizoram or till further Orders, whichever is earlier. The contract is liable for extension, based on satisfactory performance of duties.

2. Since the contract is with a consolidated remuneration, allowances and pension benefits admissible to regular employees of NIT Mizoram shall not be admissible, as per the extant rules.
3. Vide APPENDIX – II of the CCS (Leave) Rules, 1972 and as amended from time to time, the person engaged as Junior Accountant – on Contract may be liable to avail **Earned Leave of 2.5 days per month** during the engagement period. Encashment of Earned Leave at credit shall not be admissible, as per the extant rules.
4. No service benefits at par with the regular employees of NIT Mizoram shall be admissible.
5. The engagement is liable to be terminated by the National Institute of Technology Mizoram, without assigning any reason thereof.
6. The contract of the person engaged may be terminated with a one month's prior written notice to the NIT Mizoram. The NIT Mizoram will be at a liberty to terminate the contract of the person at any time, with immediate effect, by paying the consolidated remuneration of one month, in lieu of one month's notice.
7. If required, in the public interests, the Junior Accountant – on Contract may have to work on holidays including Saturdays / Sundays.
