ORDER

Consonant to the decision of the 14th Meeting of Senate dated 11th November, 2020 vide SNT 14.3, through Circulation, and the 12th Senate held on 24.7.2020 under SNT 12.10 Online Academic Classes during the Odd Semester of the Academic Year 2020-21 was continued for the UG 2nd Year to 4th Year, and the Ph.D Course Work, due to Covid-19 Pandemic.


As the Covid-19 Pandemic has abated, the End Semester Examinations for the Odd Semester, 2020-21 of UG 2nd, 3rd and 4th Year shall be conducted w.e.f 30.11.2020 as per the decision of 11th Senate vide SNT 11.3 dated 29.5.2020.

1. For all Theory Courses of B.Tech, the End Semester Examination shall be based on assignment or project based question (if feasible) of 30 marks followed by Viva of 20 marks.
2. For Practical Courses of B.Tech, the End Semester Evaluation shall be as per the discretion of the Course Coordinator and the respective HoDs.
3. Evaluation of B.Tech and M.Tech projects shall be done using PPT and Viva. Soft copy of the presentation has to be submitted by the students to the HoDs.

For M.Tech First year (CSE, ME, ECE, EEE) and Ph.D Course Work, the Online Mid-Semester Examinations procedure shall be as per the decision of SNT 11.2 and shall be followed as under:

1. Instead of regular Mid-Semester Examination of 30 marks for 1 ½ hours, an online Mid-Semester Examination of 15 marks shall be held for Final Year UG students for one-hour. Rest of the 15 marks shall be based on assignments.

The Course Coordinator shall preserve the documentation of the implementation of the plan of evaluation for respective courses.
