
CIRCULAR

In continuation to the previous Order/Notice/Circular issued amidst the COVID-19 pandemic crisis and in compliance of the Guidelines on SoPs issued by the Govt. of Mizoram and Ministry of Home Affairs, Govt. of India, all fraternity of NIT Mizoram are hereby informed to follow the under mentioned guidelines:

1. As per the advisory of the Govt. of India and the Govt. of Mizoram, the policy on **Government/Institutional/Community Quarantine for minimum 14 days + another 7 days Home Isolation/Quarantine with an advisory to do daily self monitoring of health status, subject to result of RT-PCR Test**, shall be applied to all the fraternity of NIT Mizoram who had travelled outside the Headquarters i.e Aizawl after 19th March, 2020.
2. On their return to the Institute, after completion of the 14 days Government/Institutional/Community Quarantine + 7 days Home Isolation/Quarantine period and clear in all respect from COVID-19, all the fraternity members of the Institute shall report to the General Physician, Health Care Centre, positively, who will undertake the necessary medical protocol, as required. As a means to ensure COVID-19 free Institute, **all are advised to refrain from entering the Institute directly without enduring the nCOV stipulated Standard operating Procedures (SoPs)**.

The General Physician shall certify on their fitness to rejoin the Institute and the Certificate along with the Quarantine Facility Completion-cum-COVID-19 Free/Negative Certificate shall be submitted to the undersigned.

If the case merits, the General Physician, Health Care Centre shall liaise with the Govt. of Mizoram, Dept of Health & Family Affairs or Nodal Officer, IDSP Mizoram, after consulting the Administrative Dept of the Institute.


