1. For Full-Time (Regular/Self-Financed/Sponsored) candidates:
 - (i) For candidates under employment, self-Declaration certificate for leaving the job by the candidate (s) and certified by the employer to be uploaded.
 - (ii) For candidates not taking up any employment, undertaking as per the format provided in the website shall be uploaded in the ERP.
2. Mutual consent of both the student and Supervisor (s) should be given by the candidate vide the format provided in the website.
3. Migration Certificate to be uploaded in the ERP.
4. Category (Caste) Certificate to be uploaded in the ERP, if applicable.
5. OBC (NCL) Certificate issued on or after **April 1, 2026** (01.04.2026), if applicable.
6. Aadhar Card to be uploaded in the ERP.
7. Physical verification of the documents uploaded shall be conducted by the concerned supervisor (s), and shall be submitted to Academic Section.
8. As per MoE DO No. 1-15/2009 (ARC) pt III dated 18.04.2024 and vide Institute Notice No. NITMZ/ACAD (8)/2023/833 dated 09.05.2024, the Ph.D student (except part-time mode) shall execute the Online Anti-Ragging Undertaking available at www.antiragging.in. The Anti-Ragging Undertaking Reference Number along with Pdf copy of the Undertaking is to be uploaded in the ERP Portal.
9. Physical presence is a must for Full-Time (Regular/ Self-Financed/ Sponsored/ Project Staff and Part-Time) candidate (s) during the admission/ registration.
10. The candidates need to bring all the original documents during admission/registration/physical verification.
11. The format for physical verification of the documents is provided in **Annexure-I**, which is available along with the notice.
12. Admission of the candidate shall be subject to cancellation in case of any unauthenticated documents found.
