NOTICE

All B.Tech, M.Tech, and Ph.D. students are hereby informed to strictly adhere to the course registration dates as mentioned in the **Academic Calendar of NIT Mizoram**. All formalities and fee payments must be completed within the prescribed deadlines. It is mandatory for all students to be present on the Institute campus during the course registration dates, for **Odd Semester, 2026-2027**.

Important Points:

- 1. Documents and Fees:** Students must ensure that their Income Certificate along with Income Affidavit, Anti-Ragging, Mess Dues, and necessary fee payments are completed before the course registration dates.
- 2. Financial Support or Educational Loans:** Students availing financial support or educational loans from external sources must proactively communicate with the concerned authorities to ensure the timely release of funds.
- 3. Late Registration Penalties:**
 - A penalty of **Rs. 2,000/-** will be imposed for registration delayed by up to 7 days.
 - A penalty of **Rs. 10,000/-** will be imposed for registration delayed beyond 7 days.
 - **After two weeks, no course registration will be permitted, and no late fine waiver applications will be entertained.**
- 4. Medical Emergency:** Late registration due to medical emergencies may be allowed subject to verification and approval by the competent authorities. However, medical or personal reasons will not be considered for a waiver of the late fine; late registration, if ever permitted will be with the applicable penalty.
- 5. Backlog Subjects:** It is the responsibility of students with backlog subjects to complete their course registration within the prescribed deadlines.
