Anti-Ragging Undertaking (Compulsory for all):

1. Generate the Anti-Ragging Undertaking Online for National Institute of Technology Mizoram (U-0617)

Step 1: Click 1 <https://www.antiragging.in/>

Step 2: On the homepage, click on “Undertaking”.

Step 3: Click on “Register” to start the process of filling out the anti-ragging affidavit.

Step 4: Click on “University and select your university name from the list.

Step 5: Fill in all the required details:

Annexure- 2

Income Certificate (if applicable):

Income Certificate (For less than 1 Lakh category and Between 1-5 Lakh category), to be issued by the State Govt./Competent Authority **for the financial year 2025-2026** and shall be valid for academic year 2026-2027.

NOTE:

- **Income Certificate should be in the name of the parents** of the concerned student (s). Student's name will not reflect on the Income Certificate.
- The income certificate would be required to be certified by an authorised officer **not below the rank of Tehsildar** in the States/UTs.

In addition to Income Certificate, it is mandatory to submit **an affidavit** on Rs. 100/- non-judicial stamp paper, signed by the parents declaring the income for the financial year 2025-2026, for claiming waiver of tuition fee.

OBC-NCL Certificate and EWS Certificate (if applicable):

- The Certificates shall be issued for the financial year 2025-2026 and valid for academic year 2026-2027.
- The OBC-NCL / GEN-EWS certificate shall be issued on or after April 1, 2026 / a Government issued, online verifiable certificate with date of validity till August 31, 2026 or the day of physical reporting at the admitting institute, whichever is later (for NIT+ system) by the competent authority in the prescribed format. The name of the caste (OBC) should have been listed in the central list published by the National Commission for Backward Classes, Government of India, to avail the benefit of the said category in JoSAA 2026/ CSAB 2026.
- The income and assets of the families would be required to be certified by an authorised officer not below the rank of Tehsildar in the States/UTs.
